

## ONTARIO HORTICULTURAL ASSOCIATION DISTRICT 10 THAMES VALLEY PROXY AUTHORIZATION FORM



At the Special Meeting/AGM of the OHA District 10 Thames Valley, each Society/Club shall be entitled to two voting delegates; any Society/Club having membership exceeding one hundred, shall be entitled to an additional delegate for each fifty members. Society/Club membership counts shall be based upon reports filed for the previous year with the Ontario Horticultural Association.

In the case(s) of a Society/Club which comes into existence and is incorporated by OMAFRA after January 1<sup>st</sup> and before the Special Meeting/AGM, the membership numbers used at the time of incorporation by the Society/Club will be used to determine voting entitlement for this current meeting only.

If a Society/Club has fewer voting delegates attending the Special Meeting/AGM than it is entitled to, this Proxy Form is used to designate who will use the remaining votes.

If the Society/Club wishes to ask a voting member of the Society/Club or a voting member of another Horticultural Society/Club including their District Director to be the Society/Club's proxy, use the form on page 2.

**NOTE**: Proxy votes regarding a resolution usually become invalid if the resolution is amended during debate unless specifically indicated to the contrary on this form.
